**Wrentham Day Ball Drop  
Official Rules**

Ball Drop

A maximum of 1000 golf balls will be sold for the price of \$10 each online at [www.wrenthamwest.org](http://www.wrenthamwest.org). All golf ball purchases are final and non-refundable. All purchased golf balls will be individually and uniquely numbered and randomly placed into two bins for the ball drop. To find out the specific numbers of the ball(s) you have purchased, visit [www.wrenthamwest.org](http://www.wrenthamwest.org). During Wrentham Day, on Saturday, September 12, 2009 the purchased, individually numbered golf balls will be dropped from a height of approximately 65 feet off of the Wrentham Fire Truck Ladder onto the preschool playground at the Wrentham Delaney Elementary School. The registered golf ball owner whose (numbered) ball is found nearest the target will be awarded the Grand Prize, \$1000. If more than one golf ball lands equal distance to the target, those participants will divide the winnings equally. The golf ball closest to the target will be determined by measuring the distance from the target to the golf ball by our **Wrentham Elementary Schools Trust, Inc. (WEST)** official judge. Decisions by our judge on all aspects of this event will be final and binding.

Odds of winning depend on the number of valid entries received by the time of the Ball Drop. Odds of winning are 1 in 1000 or better.

Conditions and Limitations

1. The event is open to participants 18 years and older as of the entry date.
2. Entry ownership of ball is non-transferable. Purchaser may enter more than once and need not be a resident of the state of Massachusetts. Only one (1) individual may be identified as an entry owner. Entries may be purchased via the Internet, [www.wrenthamwest.org](http://www.wrenthamwest.org).
3. Odds of winning depend on the number of valid entries received up to 1000.
4. All federal, state and local laws and regulations apply.
5. The winner(s) will be required to provide appropriate photo identification and name, social security number, and address. The winner(s) will be required to complete, sign and date a Form 5754 before winnings will be awarded. If all needed information is not provided the winner(s) maybe subject to backup withholding. The winner(s) will receive a W-2G which will be reported to the Internal Revenue Service as required by law.
6. Decisions by **WEST's** official judge will be final and binding.
7. Winner need not be present and will be notified via phone, mail or email from contact information supplied. If a winner cannot be located or fails to claim the prize within fourteen (14) days after notification, the prize will be forfeited and awarded to the next closest ball or balls to the target.
8. All entries become property of **Wrentham Elementary Schools Trust, Inc. (WEST)** and will not be returned.
